Statements by Courts of Law (Selected)

In re Kizer Excavating Co. v. Stout Building Contractors, LLC, Case No. 20CV17226, filed on February 17, 2021,

The Honorable Judge Susie L. Norby said, on page 2, "The most controversial alteration to the Agreement appears in paragraph 1.5 on page 1. At first glance, that alteration is a confusing semi-spiral line that simultaneously circles and crosses over the numerical dollar amount (\$139,077.00). Based on the persuasive testimony of the handwriting expert, though, the court concludes that it was intended to be a full circle around the number, not a line-through....Witness Jacqueline Joseph challenged the court's reference to the lower left extremity of the pen stroke as 'the tail' in a question meant to clarify the location of the '4th line.' By refuting the assumption implicit in the court's word choice, she drove home that the true 'tail' of the pen stroke was at the opposite extremity."

In an unpublished opinion, The United States District Court, District of Oregon,

In Mohamad Hariri v. Portland State University, filed March 2, 2017, the Honorable Paul Papak, United States Magistrate Judge, issued his OPINION AND ORDER, and on page 7, referenced the Declaration of Jacqueline Joseph: "... a board-certified forensic document examiner opined that the handwriting of the person who wrote the examination ... bearing Hariri's name differed significantly from Hariri's and had no forensically significant similarities to Hariri's ... The forensic document examiner offered her opinion to the highest possible degree of confidence, opining that the possibility that the handwriting was Hariri's was entirely eliminated."

In re Marriage of Freeman, Case No. 2016 DR 30136, Douglas County District Court, Colorado, filed on December 1, 2016,

The Honorable Judge Gary Kramer said, on page 7, "Jacqueline Joseph, whom the court accepted as an expert in forensic document examination ... The Court concludes that Ms. Joseph's testimony was more persuasive than Mr. Lewis' testimony." Mr. Richard B. Lewis said he was trained in Questioned Document Examination by the U.S. Secret Service.
